ARENA RULES/WAIVER

A membership allows member(s) to access the Saddle Club Arena grounds and use the arena when not in use for organized events. The member(s) must do the following:

- DO NOT use when arena is wet;
- Leave the arena free of items - barrels, flag poles, etc must be removed from the arena;
- Pick up all trash;
- Make sure all gates are latched/locked when you leave.
- NO Alcohol is allowed at the Saddle Club grounds; and
- Report any issues to an officer/director.

All members listed on the front of this form wish to participate in horse shows/events/classes at Rayville Saddle Club and Rayville Equestrian Club for the year 2023. All understand that during portions of these shows/events/classes, they will be in close proximity to one or more horses, which may expose them to some risk of injury, due to the nature of horses, the facility, and the classes/events/activities in which they will be engaged. In consideration of Rayville Saddle Club and Rayville Equestrian Club allowing each to participate at the club's shows/events/classes, I, on behalf of myself, and my heirs, administrators, personal representatives and assigns, if any, do hereby agree to hold harmless, release and discharge Rayville Saddle Club and Rayville Equestrian Club, which includes its officers, directors, club members, volunteers, sponsors, judges, other exhibitors, agents, representatives, affiliates and insurers, of and from all claims, demands, causes of action and legal liability whether known or unknown, anticipated or unanticipated, of the Rayville Saddle Club and Rayville Equestrian Club. I shall not bring any claims, demands, legal actions or causes of action against Rayville Saddle Club and Rayville Equestrian Club for any damage(s) or loss(es) due to bodily injury, accident, illness, paralysis, escape, death, loss of personal property and expenses thereof which may occur while participating in any and all equine shows/events/classes/activities arising out of my participation in any show/event/class or while using said arena grounds. I (Member/parent/guardian) further agree to abide by all safety instructions, and to wear any safety equipment including an ASTM-II helmet in all timed events. Under Missouri law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risk of equine activities.
